RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT BY SIGNING THIS DOCUMENT YOU WILL WAVE CERTAIN LEGAL RIGHTS. PLEASE READ CAREFULLY!

Description of events(s) covered, herein collectively called the "PCSL": All events sanctioned by and/or promoted by the Portuguese Canadian Soccer League.

In full or partial consideration for allowing me to participate in, all related events and activities of the PCSL; I hereby warrant and agree that:

1. I am familiar with and accept that there is the risk of serious injury and death in participation, whether as a competitor, student, official or worker, in all forms of the sport; and
2. I have satisfied myself and believe that I am physically, emotionally and mentally able to participate in this the PCSL, and that my gear and equipment is fit and appropriate for my role as a participant in the PCSL; and
3. I understand that all applicable rules for participation must be followed, regardless of my role, and that at all times during the PCSL the sole responsibility for my personal safety remains with me, and
4. I will immediately remove myself from participation, and notify the nearest official, if at any time I sense or observe any unusual hazard or unsafe condition or if I feel that I have experienced any deterioration on my physical, emotional or mental fitness, or that of protective gear or equipment, for continued safe participation in the PCSL.

I UNDERSTAND AND AGREE, ON BEHALF OF MYSELF, MY HEIRS, ASSIGNS, PERSONAL REPRESENTATIVES AND NEXT OF KIN THAT MY EXECUTION OF THIS DOCUMENT CONSTITUTES:

1. AN UNQUALIFIED ASSUMPTION BY ME OF ALL RISKS associated with my participation in the PCSL even if arising from the negligence or gross negligence, including any compounding or aggravation of injuries caused by negligent operations or procedures, of the Releases, as that term is defined below, and any persons associated therewith or otherwise participating in the PCSL in any capacity, and
2. A FULL AND FINAL RELEASE AND WAIVER OF LIABILITY AND ALL CLAIMS that I have, or may in the future have, against any person(s), entities organizations(s) associated in any way with the PCSL including the field owners and lessees, promoters, sanctioning bodies, soccer associations, or any subdivision thereof, game operators, sponsors, advertisers, team owners and other participants, and others who give recommendations, directions or instructions, or anyone or more of them and their respective directors, officers, employees, guides, contractors, agents and representatives (all of whom are collectively referred to as "the Releasees") from any and all liability for any loss, damage, injury or expense that I may suffer as a result of my use of or my presence at event facilities or my participation in any part of, or my presence in any capacity at, the PCSL, due to any cause whatsoever, INCLUDING NEGLIGENCE, GROSS NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER THE RELEVANT OCCUPIERS LIABILITY ACT ON THE PART OF THE RELEASEES.
3. AN AGREEMENT NOT TO SUE THE RELEASEES for any loss, injury, costs or damages of any form or type, howsoever caused or arising, and either directly or indirectly from my participation in any aspect(s) of the PCSL, and
4. AN AGREEMENT TO INDEMNIFY, and to SAVE and HOLD HARMLESS the RELEASEES, and each of them, from any litigation expense, legal fees, liability damage, award or cost, of any form or type whatsoever, they may incur due to any claim made against them or anyone of them by me or on my behalf, or that of my estate, whether the claim is based on the negligence or the gross negligence of the Releasees or otherwise as stated above.
5. AN AGREEMENT that this document be governed by the laws, and in the courts, of the Province in which the PCSL event(s) occurs.
